  - B. Restaurant with banquet room, additional fee above \$150.00 flat fee of \$57.00
  - C. Temporary restaurant, fourteen (14) days or less for a single fee of \$88.00
  - D. A short-term restaurant license may be issued for six (6) months at a rate equal to fifty (50) percent of the annual license fee in the event of a transfer of the restaurant. After the expiration of the initial short-term license, all subsequent licenses shall be issued for a period of one (1) year at the annual license fee.
