<p><b>Continue Opioid Mgmt</b> – Continue ongoing efforts &amp; increase training.</p> <p><b>Promote Activities for Youth</b> - As a preventative measure, consider how to increase access to &amp; involvement in youth activities.</p> <p><b>Develop local resource website</b> – Aggregate and organize resources &amp; info from community agencies/orgs.</p> <p><b>Public Education Campaigns</b> – Produce or use State campaigns on education re: Stigma, reducing substance abuse &amp; addressing social norms.</p> <p><b>Evaluate Existing Curricula</b> – Use surveys, focus groups, etc. to evaluate existing curricula in public schools and recommend changes.</p> <p><b>Promote Medication "Lock/Monitor/Takeback"</b> – Promote existing state program on abuse of prescription opioids.</p> <p><b>Licensed Addiction Counselors (LAC) in ER and in Public Schools</b> – Evaluate feasibility of LAC's in targeted areas.</p> <p><b>Appoint/Employ Coordinator</b> – Backbone support to ensure efforts are effectively accomplished.</p> <p><b>Explore Call Center</b> – To support access to information (See Website).</p> <p><b>Promote Basic Human Welfare</b> – As a preventative action, ensure housing, food &amp; transportation are available.</p>	<p><b>Establish Medication Assisted Treatment (MAT)</b> – Identify &amp; take steps to support (MAT) facility in GF.</p> <p><b>Identify optimal education needs to promote intervention</b> – Educate GF residents on how to intervene with a friend or loved one &amp; how to get help.</p> <p><b>Increase access to treatment (24/7)</b> – Ensure access to treatment when/where/how it is needed: Include identifying &amp; addressing barriers, e.g., income &amp; transportation.</p> <p><b>Increase use of Harm Reduction Actions</b> – Increase of Narcan/Naloxone distribution &amp; use by emergency responders; Explore needle exchange programs &amp; family drug court.</p> <p><b>Increase Workplace Programs</b> – To decrease stigma and increase accessibility to treatment programs.</p> <p><b>Develop political momentum for policy/funding changes</b> – Identify challenges in policy, politics &amp; funding &amp; the strategies to overcome them.</p> <p><b>Develop Distance Counseling</b> – Explore a distance counseling approach, using expertise at UND, to expand access to treatment.</p> <p><b>Develop Professional Working Group</b> – Foster a knowledge exchange &amp; personal connections between professionals in these fields.</p>	<p><b>Sober Living Homes, Traditional Housing &amp; Housing First</b> – Support efforts like Housing First and explore options for more supportive housing.</p> <p><b>Improve access to &amp; programming in corrections facility</b> – Identify actions to provide/improve mental/ behavioral health svcs in corrections.</p> <p><b>Stronger Re-entry programs</b> – Target those who are/were incarcerated with substance use disorder to reduce relapse &amp; recidivism.</p> <p><b>Encourage connection with Faith-based programming</b> – Reinforce network of faith-based orgs providing support programming &amp; share info.</p> <p><b>Develop Parent/Family Support Group</b> - Create a support group for those w/ loved ones in recovery.</p> <p><b>Enhance support systems in public schools</b> – Evaluate feasibility of increased support systems in schools for students in recovery.</p> <p><b>Implement a Recovery Community Organization (RCO)</b> – Use the <i>Faces and Voices of Recovery</i> toolkit and convene steering group.</p> <p><b>Community &amp; Children's Facility for Recovery</b> – Explore possibility of a center/facility for those in recovery &amp; for children exposed to substance use disorder.</p>	<p><b>Messaging and Protocol</b> – Create communications strategy including identifying specific target audiences &amp; messages and tailoring information.</p> <p><b>Disseminate Findings</b> – Internally and externally share the findings to educate and inform actions.</p> <p><b>Enhance Communications</b> – Internally &amp; externally, promote better communication.</p> <p><b>Identify and Analyze Data</b> – Identify and collect relative data and ensure collection is consistent and ongoing. Find trends and identify possible action steps.</p> <p><b>Use Data to enhance Awareness</b> – Support education efforts with real data.</p> <p><b>Create Dashboard with Automated Data Collection/Visualization</b> – Create an online and shareable dashboard of key indicators with visual graphics created by automated data sets.</p> <p><b>Promote Awareness of Existing efforts and Strategies</b> – Including local public school &amp; state awareness/ education strategies.</p> <p><b>Provide Support to Other Committees</b> – Support the action steps recommended by other committees with data.</p>
