BACKGROUND:

In conjunction with the approval of the Grand Forks – East Grand Forks Metropolitan 2045 Transportation Plan Update, the City Council adopted 2 specific ordinances as follows:

- Ordinance No. 4696 relating to the 2018 Street and Highway Element approved on December 17, 2018. (see attached ordinance)
- Ordinance No. 4698 relating to the 2018 Bicycle and Pedestrian Element approved on January 22, 2019. (see attached ordinance)

Following the adoption of the 2 ordinances the City Attorney informed staff that there were numbering errors relating to the elements listed on the ordinances. The attached preliminary ordinance corrects the errors, which accurately shows the 3 specific elements contained in the plan update. The intent and substance of the previously adopted ordinance do not change.

ANALYSIS AND FINDINGS OF FACT:

- The City council adopted ordinance No. 4696 on December 17, 2018 relating to the 2018 Street and Highway Element of the Transportation Plan Update.
- The City council adopted ordinances No. 4698 on January 22, 2019 relating to the 2018 Bicycle and Pedestrian Element of the Transportation Plan Update.
- After adoption of the 2 ordinances the City Attorney discovered errors in the numbering of the 3 elements contained within the plan.
- A technical corrections ordinance is necessary to establish the proper numbering of the elements.



ORDINANCE RELATING TO TECHNICAL CODE CORRECTIONS AMENDING CHAPTER XVIII, ARTICLE 8, COMPREHENSIVE PLAN; SECTION 18-0802, ELEMENTS OF THE GRAND FORKS CITY CODE OF 1987, AS AMENDED, PERTAINING TO THE GRAND FORKS-EAST GRAND FORKS TRANSPORTATION PLAN UPDATE, CORRECTING PREVIOUSLY ADOPTED ORDINANCES NO. 4696 AND NO. 4698.

BE IT HEREBY ENACTED BY THE CITY COUNCIL OF THE CITY OF GRAND FORKS, NORTH DAKOTA. PURSUANT TO THE HOME RULE CHARTER OF THE CITY OF GRAND FORKS, NORTH DAKOTA, THAT:

SECTION I. AMENDING CLAUSE

Section 18-0802(C) of the Grand Forks City Code relating to Elements is hereby amended to provide as follows:

~~(C) The Grand Forks-East Grand Forks 2040 Long Range Transportation Plan Update, which contains the following sections:~~

- ~~1. 2013 Street and Highway Element, together with all maps, information and data contained:
 - ~~A. Fare structure for transit;~~
 - ~~B. Vehicle types for transit;~~
 - ~~C. Bus routes.~~~~
- ~~2. 2007 Street and Highway Element, together with all maps, information and data contained with the switching the time period of the 17th Avenue Overpass to the later time period and placing in its place to the mid-term period the urbanizing of S. Columbia Road.~~

(C) The Grand Forks-East Grand Forks 2045 Metropolitan Transportation Plan Update, which contains the following sections:

1. 2017 Transit Element, together with all maps, information and data contained therein; with the exception that the following sections shall not be included as part of the comprehensive plan:
 - A. Fare Structure for transit
 - B. Vehicle Types for transit
 - C. Bus Routes
2. 2018 Street and Highway Element, together with all maps, information and data contained therein.
3. 2018 Bicycle and Pedestrian Element, together with all maps, information and data contained therein.

SECTION II. EFFECTIVE DATE.

This ordinance shall be in full force and effect after its passage and approval as provided by law.

SECTION III. REVISER'S NOTE.

The adoption of this Ordinance corrects errors existing in previously adopted Ordinances No. 4696 and 4698. Ordinance No. 4696 and No. 4698 are effectively repealed by the adoption of this Ordinance.
